Following the Pledge of Allegiance, Mayor McTizic turned the meeting over to Judge Boyette Denton.

Judge Denton performed the Oath of Office to the newly elected officials in the following order:

Upon completion of the Oaths of Office, Mayor McTizic called the meeting to order and asked Mrs. Rhea to call the roll. All were present.

Mayor McTizic then announced every four years we also have to appoint a Vice Mayor, City Judge and City Attorney. He then opened the floor for nominations for Vice Mayor.

The last order of business was to appoint a City Judge. Mayor McTizic made a nomination to reappoint City Judge Cathy Frost. Councilman Spinks made a motion, seconded by Councilman Crawford. All voted "Aye".

Mayor McTizic invited everyone in attendance to coming to a small reception at Simon's on the Square immediately following the called meeting.
