Old Business:

a. LPRF Grant

A2H held the bid opening for the LPRF Grant for Construction of the amphitheater and boat ramp at Sand Beach Lake. Six bids were submitted and GTG Construction got the bid in the amount of \$568,948.27. The pavilion will be bid out separate. <u>Councilman Golden made a motion, second by Councilmember Rhea to go forward with GTG Construction. All voted "Aye".</u>

b. Update on Pleasant Creek Run multi-use sportsplex

No official action has been taken on this matter. A feasibility analysis was completed by Cumberland Securities and Economic Impact analysis completed by Younger & Associates. Reports are being reviewed and discussed along with USDA. The Utility Department renewed their contract with Retail Strategies that will also help with this project.

New Business:

a. Transfer of K-9 Officer Jules

Chief Jones is wanting to transfer K-9 Officer Jules to surplus and retire him as out of service. <u>Councilmember Rhea made a motion, second by Councilmember McKinnie to move K-9 Officer Jules to</u> <u>surplus and retire him as out of service. All voted "Aye".</u>

b. Purchas of New Sky Cop trailer and Police Department renovations

Chief Jones would like to purchase a new sky cop mounted mobile trailer the cost for both would be \$36,850.33. He also would like to do renovations for a Criminal Investigation Division office in the amount of \$7,500.00. Total amount for both purchases would be \$44,350.33 which \$22,500.00 will come from LESO account and \$21,850.33 will come from the General fund. <u>Councilmember McKinnie made a motion, seconded by Councilmember Williams to purchase sky cop trailer and make renovations to the police department. All voted "Aye".</u>

There being no further business, <u>Councilmember McKinnie made a motion</u>, <u>seconded by Councilmember Woods</u> to adjourn the meeting. All voted "Aye."
